## **Explanations:**

1. The hired apparatus and equipment may only be operated by the crew of Fire Brigade of the Port of Gdynia Authority S.A. (hereafter referred to as: Port Fire Brigade), with the exclusion of Section B item 1 of Price list for the services of Port Fire Brigade of the Port of Gdynia Authority S.A. (hereafter referred to as: Price List).
2. Services are conducted on the basis of a written order or contract agreement.
3. All prices specified in the Price List are given in PLN.
4. All prices specified in the Price List are net amounts.
5. Fees are charged for every hour, at the rates set out for working hours of apparatus, equipment and personnel.
6. During the first 24-hour period, a fee for hiring a containment boom is charged at the full 24-hour rate. For the next 24-hour periods, a fee is charged for each 6-hour period in the amount equal to a quarter of the full 24-hour rate.
7. The length of service time is counted from the moment of departure of the apparatus or equipment with the crew from the base of Port Fire Brigade to the moment of its return.
8. In case of soiling the hired containment boom, the total hiring fee will be increased to include the time of cleaning and maintenance of the boom along with costs of used materials and the cost of disposal of pollutants.
9. Services not included in the Price List will be charged according to separate arrangements.
10. Terms and prices of the services provided by the Port Fire Brigade, carried out on the basis of standing orders, will be determined according to separate arrangements.
11. Reimbursement of costs of the removal of contamination of environment is calculated on the basis of Section A of the Price List and the actual consumption of resources and materials used.
12. The rates for services specified in the Price List do not include costs of extinguishing agents or other materials, so these will be charged according to their actual consumption.
13. The timing of commencement of Port Fire Brigade's service should be given in writing by the Ordering Party. It should specify the date and time of commencement of the service. In case of cancellation or delay regarding the date of service commencement, that was commissioned to Port Fire Brigade, the order may be cancelled or postponed no later than 6 hours prior to the scheduled commencement of service. In case the reservation is cancelled later or the order is changed, a fee for the waiting in readiness time will be charged, at the rates given in Section A points 1-12 of the Price List.
14. Price for services, which require the use of fire-fighting pumps installed on the fire truck, will be increased by 20% from the initial rate set in items A.4 and A.5 of the Price List.
